CONNECTING SCRIPTS

Pam talking vs texting

ON THE PHONE--

- “Hey Mary! I’m just checking in to see how things are going. How are you guys navigating this whole Shelter at Home thing?”
STOP AND LISTEN! If appropriate...move to the invite script.

TEXT/EMAIL/FB MESSENGER---

- “Hey, Sue. It’s been a while since we have chatted. Do you have time for a phone call this afternoon? What time works best for you? I’d love to catch up!”
- “Hey, Julie. How are things going? How are you managing e-learning these days? I’d love to catch up sometime. Are you free later today?”

INVITING SCRIPTS

“Hi Susie. It’s so great to hear your voice again! I don’t know if this would be of interest to you or not ... But maybe you might like to look at starting a home business like I’m doing ...

I know people who develop home businesses and the extra income really comes in handy. Even an extra \$300-550 per month can really make a difference. It’s very rewarding and so flexible!”

"Hi Joy, this is Lisa. I remember you mentioning that you are working on saving for your retirement, and I thought of you and wondered how that is going ... Tell me about that.

We have an online presentation tomorrow night that might be of interest to you. The Chairman of my company will be presenting a Stimulus Plan to help people earn some much needed income over these coming weeks.

I have a feeling you might find the information of value. The event will last about 30 minutes. Would you like me to send you the link?”

INVITING SCRIPTS -- continued

Hey, Janet. How are you? I'm calling to see if you are aware that Shaklee has launched a stimulus plan that allows people to earn \$1000.

Do you need to know about that?

Hi Lisa. I'm calling to let you know that you'll be receiving a cash bonus from Shaklee. If you are on direct deposit, the money has already been sent to your bank account.

If not, you'll be getting a check in a few days. Would you like to receive another check like that next month? I'd like to talk to you about what it would take to earn that amount of money again next month and maybe even more....

INVITING SCRIPTS (con't)

Hi Dana. How are you? I'm calling because I just received my monthly bonus check from Shaklee and I see that you will also be receiving a bonus check this month.

If you are on direct deposit, the money has already been deposited into your bank account. If not, you'll be getting a check in a few days. Would you like to receive another check like that next month?

I'd love to talk to you about what it would take to earn that amount of money again, next month, and maybe even more....

FOLLOW-UP SCRIPTS

“ I was thinking about our conversation last week. I just received notice about a special event on starting a home business ... and wanted to ask if you have ever thought of working from your home?

 If I were to send you some information... would you consider it and let me know by tomorrow, if you can attend?”

 “If you would like to know more about the business, I’d be happy to set up a 3-way call with my upline, Becky.

 She is an amazing teacher and very successful in Shaklee. She could tell you more about how all of this works and can answer any questions you might have.”

Visualize –

- your name in the newsletter .. and the list of all your leaders beside it
- Jeanne – practiced her speech when she would become a Master

See yourself feeling comfortable in **conversation** ... live, ear-to-ear conversation

Then We Want toPolish Up Our Inviting Skills

Week 2 **Inviting** –

- **Relationships** are built when there is **common experience** or interest ...

With Covid-19 .. We ALL have a common goal to stay well and help get the economy back on its feet, staying connected.

- Connection occurs when we learn to discuss in CONVERSATION – the “ why of it “ and not the “ what of it”

Difficult to convey via text

angie

There are 2 ways to identify business partners.

Approach them directly

CALL –

- Share why you want to speak with them about your business.
- Why you want to assemble a team of people to join you in teaching others about wellness and prevention .. especially now
- Why you admire them
- Not sure if of interest to them or not
- Then just ask them to take a look

Create ways to meet people

- Create events and activities
- Offer incentives for people attending.... And people who invite others... and for referrals.
- Set up 3 way health calls
- Create Wellness Challenges with pay-to-enter and cash prizes

The Business Conversation

Not always necessary to have formal business presentation

- Mostly people join us because they hear our story,
- and how we feel about our business and its benefits ...
- and why we would be honored to have them join our teams.

Then we simply ask them if they would like to take a look.

This is how our process begins... finding wonderful people

Massive Shaklee organizations are built on only 3 - 4 strong deep legs of leaders.

Quality over Quantity

Work on telephone and communication skills every day.

Challenges We Could Encounter when reaching out

Angie

Lot of goodness happening

Lots of acts of kindness, gratitude, generosity, care and appreciation for the first responders, and family, etc.

- People feeling stressed about job insecurity
- Moms feeling overwhelmed with home schooling
- Anxiety about Pandemic
- Loneliness and isolation

Responding to Challenges/Concerns

Our job is always to be an advocate for them & solve problems

- Allow people to “ empty their bucket “ .. And just receive..
Even ask “ is there anything else?”

Accept full responsibility ... Let go of our need to be right ..

Apologize for offending even if unintentional . When there is a problem --- Give explanations .. not excuses (back orders)

Then we offer some possible solutions (3 options) (Jeanne’s example)

Could I just put my Shaklee hat on for a minute? or

I’m working on Shaklee right now and came across your name ..

The Conversation

Empathy – putting ourselves in another’s shoes .
“What would I want to hear if I were in their place?”

How are you managing?

pam

How are you keeping your immune system strong?

Discuss appropriate products, Shaklee standards and back orders.

If \$ is tight, offer our budget products... and referrals ...

Who do you know who might be at higher risk?

-- over 65 .. Parents ?, grandparents? , people working in medical, grocery, essential businesses, health issues, etc .. Now we are learning – people overweight/ diabetes/ high blood pressure, especially vulnerable.

Contact and Follow up

Through referrals, they are experiencing the business

Leaving Messages

I am calling to tell you about 3 things:

- First to check in and see how you are doing
- Second to see how you are keeping your immune system strong ... and if you need any information for that
- And last, to see if you or someone you know may be looking for some additional income right now .. Shaklee just announced a special Stimulus Plan for that.
- OH .. And one more thing .. -- I wanted to ask you when your birthday is as Shaklee will be giving you a free product when you place an order during your birthday month.

Qualification #2 –




